## **Development Report**

# **September Executive Committee Meeting**

#### Grants

- Meetings will be scheduled with Jackie Berry from the 3M Foundation, Jeff Peterson from the Hardenbergh Foundation and Paul Verret at Katherine B. Andersen. We will submit grant applications to these foundations in September. If you have any connections and are willing to reach out on MISF's behalf please let us know. We can provide a copy of the grant application.
- We have been assigned a new foundation officer at General Mills, Allison Olson. This is our fourth in four years. We received an invitation to apply for a grant for their fall grant cycle. Grant applications are due September 13th.
- In May we submitted an LOI to the Gertrude R. Shiely Charitable Trust. We received a letter back from Tina Jacobsen, Trustee for the Trust, with a copy of their application form and an invitation to submit a grant. Grant due date is November 11<sup>th</sup>.
- We have scheduled monthly calls with Foundation Search to assist in building a prospect list of new grant funders.

#### **Honor Fund**

- Annual Appeal letter will be mailed in September.
- The 2016-2017 Annual Report will be mailed out to past donors, President's Cabinet and Board members in mid-November. A PDF of the Annual Report will be emailed out to all member school leaders.

## **Sponsorships**

- Raised \$6,250 in STEM Education Conference Sponsorships with a goal of \$7,000. Three colleges who participated as sponsors last year declined this year, but participated as breakout session presenters. Also, a \$1,500 sponsor from last year moved to the \$500 sponsorship level because of a decline in business but hopes to be back up again next year.
- We have reached our \$16,000 sponsorship goal for the School Leadership Conference. We are continuing to reach out to prospects with hopes to exceed that goal. We received \$10,000 from the Richard M. Schulze Family Foundation in the previous fiscal year which we have put towards this year's conference as well as \$8,000 from 3Mgives.

### **Board Giving**

- Goal of 100% participation in Board giving by fiscal year end June 30, 2018
- Work with Board to continue making new corporate, individual and foundation connections.
