Development Report December 2018 Executive Committee Meeting

Grants

- We met with Jeff Peterson from the Hardenbergh Foundation, and submitted a grant application. We expect a response in December.
- A meeting is scheduled in December with Jackie Berry from the 3M Foundation to discuss prior year outcomes and future funding.
- Paul Verret from the Katherine B. Andersen Fund declined a meeting and indicated they would consider funding for next fiscal year. The most recent gift of \$50,000 was received in December 2017 and was intended to support general operations over the next two year period.
- Tim met with the WEM Foundation and learned that we do not fit their funding priorities at this time.
- On Aug. 14 a letter of inquiry was submitted to the St. Paul Foundation to submit a full proposal for a Management Improvement Grant. A follow-up letter was sent in October, awaiting response.
- A 6 month progress report was submitted to The Schulze Foundation in October as well as an LOI for funding in 2019/2020. We were invited to complete a grant application. The grant application for the spring 2019 Cycle was submitted on Nov. 30. We should hear back in May, 2019.
- Bremer Foundation LOI was submitted on 11/16/18.
- Tim spoke with the Trust Officer from the Gertrude R. Shiely Charitable Trust and we will plan to submit an application on May 1, 2019.
- A grant prospect list has been created. Many of these grants require a LOI to be submitted prior to applying for a grant. See grant timeline for more details.

Honor Fund

- Annual appeal letter was mailed on Nov. 2, 2018.
- We received a \$30,000 gift from a generous donor a 50% increase.
- Setting meetings to connect with major donors.
- The 2017-2018 Annual Report will be mailed the 2nd week in December to past donors, President's Cabinet and Board members in mid-November. A PDF of the Annual Report will be emailed out to all member school leaders.

Sponsorships

- We raised \$19,000 in sponsorship for the School Leadership Conference, exceeding our goal by \$2000.
- We have secured a year-long sponsorship with St. Mary's University. They will become a leadership sponsor for the 2019 School Leadership Conference, and the professional development sponsor for 2019-20.

Board Giving

- Goal of 100% participation in Board giving by fiscal year end June 30, 2019.
- Board Annual Appeal mailed out November 20th.
