Several key priorities and enhancements to our organization were implemented this year, which has further extended our mission.

- Piloted the MISF Community Partnership to Advance STEM Learning with partner organizations Science from Scientists and The Bakken. These partnerships brought strong curricular and practical STEM learning to schools across our diverse membership
- Member retention remained at a robust 94%
- We provided more than \$100,000 in direct funding support via STEM grants to schools. MISF has now funded more than \$1,100,00 in STEM projects and programs in member schools in the last 12 years

• Invested in a sustained legislative presence to ensure the rights, resources and best interests of students, educators and leaders in private and independent schools are respected, recognized and defended




