MDE Science Update for March 2021 Dear Friends of Private and Independent Education:

MISF has announced the slate of recipients for the **2021 Private and Independent Education Awards**. The individuals and programs being recognized are shining examples of those found in private and independent school communities across Minnesota. I hope you will take time to join the virtual awards event on Thursday, April 29, from 7:00-8:00pm. If there's ever been a time to recognize leaders, educators, staff and volunteers, this is the year! It's guaranteed to be an affirming and inspirational production. Thank you to our generous sponsors and partners who support this event, MISF's only fundraising event of the year.

As of this writing, the Minnesota Department of Education (MDE) is awaiting approval from the US Department of Education (USDE) on the state's Emergency Assistance for Nonpublic Schools (EANS) application. Once approved, all federal funds must be approved through a legislative process. MISF has been in close communication with MDE to ensure dissemination of information is clear and timely. As noted in last month's newsletter, here are key items for schools to know.

Some key points on this program that are different than the CARES Act:

- Minnesota Department of Education (MDE) will administer the program, not the local school district. There will be a dedicated staff person at MDE to handle EANS process.
- MDE has a dedicated page to all federal funds and programs, including a specific EANS section <a href="https://education.mn.gov/MDE/dse/health/covid19/cares/">https://education.mn.gov/MDE/dse/health/covid19/cares/</a>
- Once the application is approved by USDE, the state will have 30 days to develop the application, guidance and distribute to nonpublic schools in Minnesota
- Nonpublic schools have 6 months to complete the application and submit to MDE for approval
- <u>Preliminary allocations</u> are based on a formula of total student enrollment, with emphasis on free and reduced priced student enrollment
- Eligible expenses, including reimbursement categories, can be found in section D (pages 10-12) in the FAQ document

- Schools that participate in the second round of Paycheck Protection Program (PPP) loans are ineligible to participate in EANS
- MISF has recommended that MDE host a webinar


